4. Incomplete/incorrect application forms will be summarily rejected.
5. The applicants should have a personal E-mail ID and Mobile Number. National AYUSH Mission will send intimation regarding interview, written examination and any other matters related to recruitment process only through the E-mail provided by the applicant.
6. National AYUSH Mission (NAM) under any circumstances will not entertain the information if any furnished by the applicants subsequently.
7. If any discrepancies are detected during the scrutiny of the application/ candidateship will be rejected even though the recruitment process is at final stage.
8. The applicants should not furnish any false, tampered, fabricated information or suppress any material information while filling the application form. If the particulars furnished in the application form do not tally with the original document produced by the applicant, His/ Her application will be rejected. If any candidate possesses equivalent qualification the equivalency certificate shall be produced along with the application.
